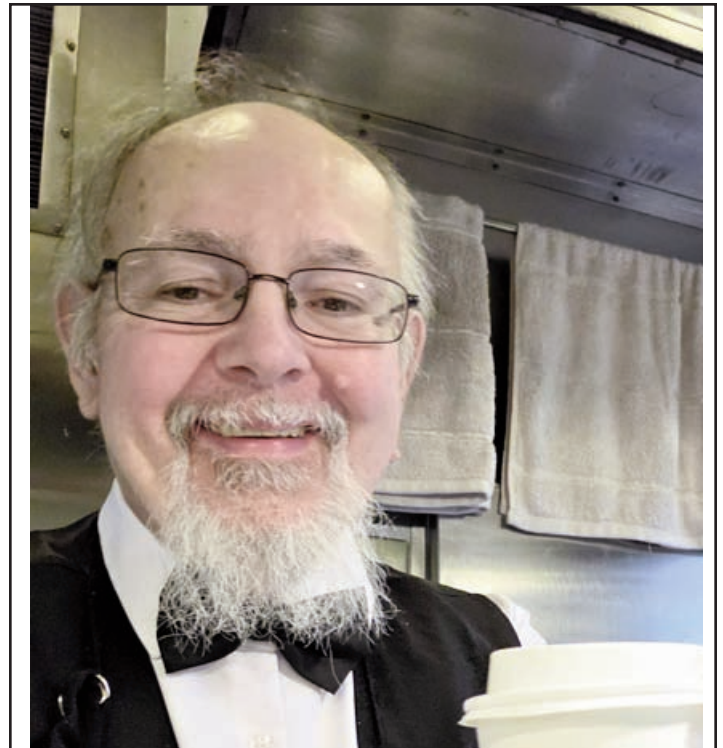

Illinois Terminal Division



I was born and raised in Decatur, IL. Having grown up only a block from the Wabash main to St. Louis and a great-grandfather who was chief draftsman at the Wabash, my interest in trains was natural. I received my first train set when I was 6 and I was hooked. As soon as I could drive, I made my way over to Monticello and joined the Monticello Railway Museum (known as M&SV Ry at that time).

Graduation from High School saw me moving to Champaign and the parents moving to Florida. After two years at the University of Illinois I got an offer to go to work for the Illinois Central Gulf as a research assistant in the Mechanical Dept. That saw a move to Richton Park. When Southern Railway decided not to buy the ICG, the ICG had a big layoff, myself included. The good thing that happened is I

got picked up by Southern Railway Research and Test Department, in Alexandria, VA. That saw a move to Springfield, VA.

The job was operating the R-3, a hi-rail rail wear test vehicle. Typical week would see me fly out Sunday night to where the R-3 was parked, test rail Monday – Thursday and fly home Friday. I soon worked a deal that had me two weeks out, testing rail M-F for two weeks, then three days off. In 1984 I got an offer from Pulse Electronics, in Rockville, MD to come to work for them. I accepted and moved to Gaithersburg, MD. At Pulse I was Field Service Engineer, specifically for End-of-Train devices. 1984-5 was the beginning of the EOT's impact on the railroad's operation. UP was Pulse's first customer and I spent the first year and half with Pulse living out of a hotel in Salt Lake City. Once the EOT's got a little better I started teaching EOT classes and making test runs for new customers railroads. All-in-all travel at Pulse took over 300 days a year and involved three foreign countries. In 1989 the VP Marketing and the Engineering Manager left Pulse to form a new company in Orange Park, FL called Quantum Engineering. Within 6 months I joined them and moved to Orange Park, FL. In Orange Park I became aware of the Northeast Florida Model Railroaders and soon joined. That introduced me to the NMRA and I joined in 1998.

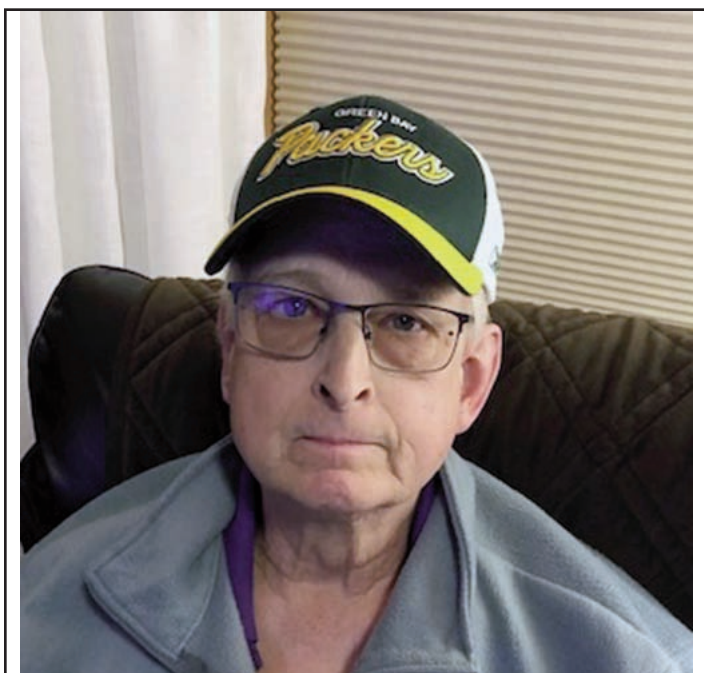
Quantum Engineering developed the first computer-based event recorder playback machines. As I wrote the software, I got to travel quite a bit teaching the railroads how to use it. In the mean time I started taking classes at the University of North Florida and I graduated in 1998. In 2018 Quantum was sold to Invensys and given to Safetran to operate. Things did not go well and I was lucky to get a call from the CMO at Norfolk Southern offering me a job. This saw a move to Kennesaw, GA, and a job at Norfolk Southern as Electrical Engineer Mechanical Dept. I quickly started attending Piedmont Division meetings and soon joined the North Atlanta Rail Barons, an operating group in the Piedmont Division.

One good thing about Kennesaw over Orange Park, is I now had a basement, first time since Decatur. Travel was quite a bit less, but on the railroad, you go when and where they tell you. In 2010 I retired from Norfolk Southern and moved to Monticello, IL. I'm life member of the Monticello Railway Museum and after spending nearly every vacation day helping them out, now I can be there

every day. I have been a director at the Monticello Railroad Museum for the last 4 years. Having the time now to make all the meetings. I never ran for office while I was working as travel could happen any time.

It's been an eye-opening experience coming from one of the largest NMRA divisions (Piedmont) to one of the smallest (Illinois Terminal). In the larger division you never ran out of ideas or model experience, never questioned the value the NMRA was giving you. I hope I can bring the same to the Midwest Division.

My name is Jeremy Reese, and I have been a model railroader since my fourth birthday when my mother bought my first HO scale layout when we lived on Mackinac Island. For the next sixteen years that 4X8 layout, cut into three pieces and sandwiched between OSB protectors, moved back and forth between school days on the island and summers at my grandparents in Rock, MI. Their house was

across the road from the Chicago & Northwestern ore line between the Marquette Range mines and Escanaba. A lifelong Yooper, I have always modeled the Upper Peninsula of Michigan in HO scale, bought my first brass engines and Digitrax Chief system when I was 15, and attended the NMRA Lake Junction National Convention in Madison, WI when I was 17, driving about 7 hours solo. I also am an avid railfan, drone and RC airplane flier, and have had my amateur radio license, **N8YP**, since 2000. I work full time as a Safety Czar, IT and everything else with a FedEx Corp ISP for the past 16 years,

I have not always been a member of the NMRA, some of the reasons are that the Upper Peninsula is a bit rural. In 1996/1997 when I first joined the NMRA, I was told that most activity in my Division was in the Detroit area. That would be a four and a half hour drive after a 18-30 minute ferry ride and a trip over the Mackinac Bridge. When I moved full time to the Escanaba, MI area, I was in the Winnebagoland Division and was able to participate with much closer activity there. After losing some family members, returning to college after ten years and working three jobs to pay for that, I let my membership lapse. I had rejoined the local club and NMRA early in 2020, and then the world changed.

I have always been into computers, taking high school computer classes in first grade and programming 3000 line code games on a Commodore 64 computer. YouTube videos, podcasts, live streams and Facebook help to connect, teach and research all aspects of the hobby.

With a large geographic region, technology could bring enhanced virtual conventions where a member could participate over the computer where travelling could not be possible due to distance, physical limitations, etc... That needs to continue, and new ideas are needed to continue that progress.
